Venita's Training Services Dog Daycare, Dog Owners Agreement

I, _____, hereby certify that my dog(s):

_____ is/are in good health and has/have not been ill with any communicable condition in the last 30 days. I further certify that my dog(s) has/have not harmed or shown aggression or threatening behavior towards any person or any dog. I have read and understand the following:

1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending Venita's Training Services Dog Daycare at Regency Kennels.
2. I further understand and agree that admitting my dog(s) to this daycare, Venita's Training staff have relied on my representation that my dog(s) is/are in good health and has/have not shown aggression or threatening behavior towards any person or any other dog.
3. I further understand and agree that Venita Bentley, Venita's Training Services and it's staff and volunteers will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog's/dogs' attendance and participation in dog daycare.
4. I further understand and agree that dogs can sometimes receive minor cuts and scratches at daycare and any problems which develop with my dog(s) will be treated as deemed best by Venita Bentley, staff or volunteers of Venita's Training Services, at their sole discretion, and that I assume full financial responsibility for any and all expenses involved.
5. I also understand that dogs will be exposed to inclement weather, so dogs may become wet or dirty.
6. In the case of inclement weather, for example temperatures of 1 degree Fahrenheit or lower, or a snowfall of over 6", daycare will be closed for the safety of the dogs and staff. Please listen to the radio for Belleville Public Schools or Van Buren Township School closings.

I certify that I have read and understand the policies of the daycare set forth on the Information and Policies page and that I have read and understand the conditions and statements of this agreement including the following:

Fees: Fees are \$25. Per day. Additional dogs are \$20. Per dog per day.

Days and Hours: Daycare is currently offered on Tuesdays from 7 am-6:30 pm. Dogs must be picked up by 6:30 pm and there is a late fee of \$2.50 for every five minutes for any pet left after 6:30 pm, unless special arrangements are made with Venita.

Reservations: REQUIRED. Cancellations made with less than 24 hours' notice will be charged full fee.

Venita's Training Services Dog Daycare General Information and Policies

The purpose of dog daycare is to provide a safe, fun, and stimulating social environment for dogs during weekday business hours. To ensure the safety and health of your dog, and other guests, we require all guests to comply with the following rules and regulations.

* Age: All dogs must be at least 4 months of age.

* All dogs over the age of 7 months must be spayed or neutered.
(Occasionally I make exceptions)

* Collars: For the safety of the dogs, they must wear quick release collars (no chains or buckle collars) with identification.

* Vaccines: All dogs must have up to date vaccines or titers. Owners must submit a copy (including expiration dates) of DHLPP & Bordetella vaccines as well as your dog's Rabies Certificate and a negative fecal test within the last 6 months.

* Health: All dogs attending must be in good health. Owners will certify their dogs have not been ill with any communicable condition in the last 30 days. Upon admission, all dogs must be free from any condition which could potentially jeopardize the health of any other dog or guests. Dogs that have had any communicable condition in the last 30 days will need a veterinary certificate of health to be admitted or readmitted.

* Behavior: All dogs must be non-aggressive, nor food or toy protective. Owners will certify their dogs have not harmed or shown any aggression or threatening behavior towards any person or any other dog(s). Please remember your pet will be spending time with other pets and safety and health of all animals is our main concern.

* Application: All dogs must have a complete, up-to-date and approved application on file prior to admittance. There is a one time, \$10.00 non-refundable application fee for each pet. This fee covers temperament testing.

* Fees: \$25. a day. Additional dogs are \$20. Per day per dog.

* Days and Hours: Currently we are only open for daycare on Tuesdays. Hours are 7 am until 6:30 pm. There is a \$2.50 charge per every 5 minutes for any pet left after 6:30 pm, unless previous plans have been made with Venita Bentley.

* Reservations: Required. Cancellations of less than 24 hours notice will be charged a full fee.
